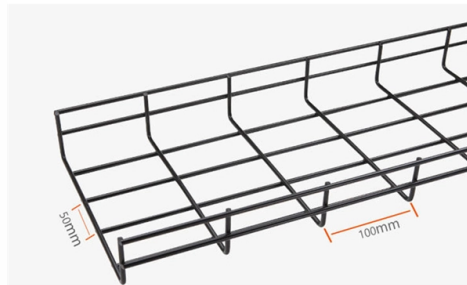


Access to the United States
