

Can the elevator electrical distribution box be placed in the stairwell



Overview

24 (F) prohibits overcurrent protective devices from being installed/located over the steps of a stairway. As long as the required working space can be maintained, a panelboard could be installed on a stairway landing as it would not be located over the "steps of. It seems like the working space in front of this equipment would be compromised by the stairs. Panelboards contain circuit breakers that are overcurrent devices. I don't see where the stairs would be a problem with the gear opposite as long as you. Under stairs no provisions to prevent other than the clearance already mentioned, but can't be ON (over) a stairway, 240.
